I am a clinical child psychologist with expertise in parenting and parenting interventions during early childhood. My scholarship focuses on minoritized populations, particularly Latinx families, who face intersecting forms of marginalization and oppression. My program of research aims to elucidate mechanisms within homes and schools that shape mental health and achievement, recognizing that inequities reflect complex, multi-factorial and dynamic pathways at all levels of a

child's ecological context. Ultimately, my goal is to incorporate influences of culture and context into models of interventions to better support Latinx parents and families.
